

This contract is between Doodle Bliss, hereinafter referred to as SELLER and, \_\_\_\_\_ hereinafter referred to as BUYER(s).

SELLER agrees to sell BUYER a puppy for the sum of \$\_\_\_\_\_ + applicable Gilbert, AZ sales tax. A nonrefundable deposit of \$\_\_\_\_\_ paid \_\_\_\_\_. Balance is due when the BUYER picks up their puppy. If BUYER is not able to select a puppy from this litter, the deposit will be credited towards a future litter.  The BUYER understands that the current wait for a puppy is expected to be around 12 months and actual timing is dependent on mother nature.

- 1) The BUYER agrees to provide a life-long commitment, comfortable environment, prompt medical attention and responsible care. This includes keeping this puppy parasite free and current with vaccinations and proper nutrition.
- 2) The SELLER guarantees the puppy to be of sound health and temperament at the time of this sale. A health record of all shots and/or worming will be provided by the SELLER. The BUYER agrees to take this dog to a **licensed veterinarian** of their choice within 72 hours for a physical examination. Should the puppy be determined to be in ill health, the cause of which the SELLER is clearly to blame, the puppy may, upon a signed written diagnosis from said licensed veterinarian, be returned for refund of the purchase price.
- 3) The SELLER assumes absolutely no responsibility for fees associated with caring for the puppy. Each puppy will come with a 1-Year Health Guarantee. The SELLER guarantees your puppy to be free from any life-threatening congenital defect or they will replace your puppy free of charge from a future litter. The BUYER must present a letter from a certified veterinarian to verify congenital defect. **The SELLER will extend to a 3-Year Health Guarantee** if the BUYER consistently feeds the puppy PawTree food purchased through the SELLER at <https://pawtree.com/doodlebliss>.
- 4)  This puppy is sold as a pet only. The BUYER agrees not to use this animal for breeding and to have it spayed or neutered at the age recommended by their veterinarian (usually 6 months to 1 year of age). Any health guarantee requires confirmation that the BUYER had their puppy spayed or neutered. A veterinarian receipt must be emailed to the SELLER before 1 year of age.  
 BUYER has received approval from SELLER and agrees to pay an additional sum of \$2000 for breeding rights.
- 5) The BUYER may contact the SELLER if any questions or concerns arise about the dog, such as housing, diet, or health. The BUYER agrees to keep the SELLER informed of any treatment as it occurs. This provides the SELLER with an opportunity to follow up on puppies and gives us important feedback and information on the health or our dogs for future generations.
- 6) It is understood at the time of sale that this is a pet quality dog and it is representative of its breed. Training classes are highly recommended for a happy relationship between the dog and family.
